

**MAKER HUB RELEASE AND WAIVER**

I, \_\_\_\_\_, am the parent/legal guardian of the minor child, \_\_\_\_\_ (hereinafter referred to as "my child"). I desire for my child to enter and participate in activities at DePaul University's Maker Hub located in the Richardson Library, 2350 N. Kenmore Ave., Room 204A, Chicago Illinois 60614 (hereinafter the "Maker Hub Activities"). I understand that this Release and Waiver covers the entirety of my child's participation in the Maker Hub Activities.

I acknowledge that I am allowing my child to participate in the Maker Hub Activities of my own free will. **I acknowledge and appreciate that the Maker Hub Activities may be hazardous with inherent dangers that no degree of care, caution, or expertise can eliminate.** These dangers include, but are not limited to the following: property damage or loss, accident, bodily injury, including, but not limited to, permanent disability, paralysis, and possibly death. These risks may result from a variety of circumstances including, but not limited to, the use or misuse of the equipment, from the activity itself, from the acts of my child, myself or others, including DePaul and its agents, or from the unavailability of emergency medical care.

I hereby warrant that, based on my own evaluation, my child has been adequately trained to participate safely in the Maker Hub Activities. I also warrant that my child has no physical infirmity or chronic ailment that would inhibit their participation in the Maker Hub Activities.

I understand that I am solely responsible for any medical, health or personal injury costs relating to my child's participation in the Maker Hub Activities. Should my child become ill or injured, I give permission for DePaul and its employees and agents to render first aid and to seek medical treatment or emergency services, as they see fit and at my cost. I am further aware that any medical, health and personal injury costs resulting from or relating to my child's participation in the Maker Hub Activities will be my sole responsibility. I agree to be financially responsible for the cost of any medical, health and personal injury costs.

In consideration of my child being allowed to participate in the Maker Hub Activities, I personally assume all of the risks in connection with the Activities, whether foreseen or unforeseen.

I HEREBY RELEASE, WAIVE, DISCHARGE AND HOLD HARMLESS DEPAUL, ITS SUCCESSORS, TRUSTEES, OFFICERS, MEMBERS, FACULTY, EMPLOYEES, AGENTS, AND REPRESENTATIVES, PAST OR PRESENT (THE "RELEASED PARTIES") FROM ANY AND ALL CLAIMS, SUITS, LOSSES, LIABILITIES, JUDGMENTS, COSTS, FEES (INCLUDING ATTORNEYS' FEES) AND EXPENSES ("CLAIMS") FOR ANY PERSONAL INJURY OR ILLNESS, DEATH, PROPERTY DAMAGE, LOSS AND/OR THEFT OR ANY OTHER OCCURRENCE ARISING OUT OF MY CHILD'S PARTICIPATION IN THE MAKER HUB ACTIVITIES, INCLUDING EMERGENCY MEDICAL TREATMENT SECURED ON MY CHILD'S BEHALF.

I ALSO AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS THE RELEASED PARTIES FROM AND AGAINST ANY CLAIMS ARISING FROM OR RELATED TO MY OWN OR MY CHILD'S ACTS OR OMISSIONS DURING THE MAKER HUB ACTIVITIES.

For the duration of my child's participation in the Maker Hub Activities, I understand that my child should act in accordance with DePaul's Policies, including the Library Patron Conduct Policies, as well as the Maker Hub Access Agreement and Health and Safety Guidelines.

I enter into this Release and Waiver for myself, my child, my heirs, my assigns and my legal representatives.
